- 1) Should the exhibitor fail to observe the terms of this contract, the fair may at their election, declare all rights Hereunder at an end shall not be obliged to refund any sum therefor paid by the exhibitor. In such an event the exhibitor may be immediately put off the grounds without notice. Should the exhibitor fail to use the allotted space, no refund will be made on any advanced payment.
- 2) The fair shall have a possessor lien on any property if the exhibitor to satisfy liabilities of the exhibitor to the Northwestern Michigan Fair. This lien may be perfected by the sale in like manner as sheriff's sales are held.
- 3) Rights under this contract may not be assigned, sold, transferred, pledged or otherwise hypothecated. Neither may the exhibitor sublicense any portion of the space the use of which is licensed to him or her.
- 4) The exhibitor as part of the consideration of this contract waives any claim of damages or liability as against the Northwestern Michigan Fair, Board of Directors, agents and employees harmless from loss or liability arising on account of acts of omission of the exhibitor.
- 5) The exhibitor certifies that they have one million dollars in liability insurance with _____ Company. Exhibitor agrees to cause the Northwestern Michigan Fair to be named as an additional insured and to furnish proof thereof to the Fair before or by the first day of said fair dates.
- 6) The exhibitor agrees to provide safety chains and secure all compressed gas cylinders away from egress doors.
- 7) Electrical hook ups shall be by standard UL approved plugs and or breakers and the cords and plugs must be in good repair with all power cords and extension cords being grounded and listed. All power and extension shall be protected from damage and not buried under ground. All other electrical must comply with the International Electrical Code and the Grand Traverse County Electrical Inspector. NO electrical hook ups shall be hand wired directly into the breaker box.
- 8) The exhibitor also agrees to the general regulations set forth on the separate cover.
